Summer Camp 2010

Thank you for your interest in having your child attend Camp Carl this summer! There is a team of people who give generously to meet the needs of children and young people who sincerely want to attend camp, but may not be able to because of finances. Our goal is to distribute the monies faithfully and to provide a way for those requesting funds to make the request comfortably. Information will be reviewed by a camp team and held in strictest confidence. The following are the steps to apply for a Camp Carl summer camp scholarship:

1. Thoroughly complete the application. The application will not be processed unless all the information is completed.
2. Attach filed tax forms for the child's custodial household for the current year (main form only, no tax schedules are necessary).
3. Mail or drop off the information to Camp Carl, 8054 Calvin Rd. Ravenna, OH 44266.
4. To expedite the registration process, please include the camper's registration form with the application.
5. Be willing to write a thank you note from the camper, written to an anonymous giver (before or after the camp experience).
6. Please do not request scholarships for multiple weeks for a child.

Once **Camp Carl** receives your application, we will **process** it according to the following guidelines:

1. Applications will be received January 1 through August 1.
2. The applications will be processed on a first-come-first-serve basis until all scholarship monies are dispensed.
3. Applications will be reviewed and scholarships awarded during the following time frames: March 1st – May 15th and again July 1st – August 1st.
4. Scholarships will be awarded based on an established income scale and reviewed by a financial professional.
5. Scholarships will be distributed in \$75.00, \$150.00, \$200.00, and \$275.00 increments.
6. Applicants will be notified about requested scholarships by mail, after March 15th.
7. Funds will be distributed based on God's provision through the generosity of others. A prompt request is preferable to assure that scholarship funds are still available.

Thank you for your interest in Camp Carl. Our prayer is that camp scholarships will be used in a God-honoring way.
